- Applications must be postmarked by July 15, 2021.
- All vendors need to provide their own tents, tables, chairs, etc. you are renting space only. Tents must be weighted down and securely staked.
- The festival area is located on the upper parcel of Crooked Creek Campground. Please be respectful of the campers and stay within the marked areas.
- All vendors are expected to participate for the full day schedule on Saturday from 10pm - 4pm, no early setups or tear downs. Food vendors may extend their hours with prior permission. If vendors leave or break down prior to 4pm your application will not be considered for future festivals. Booth setup will be 8/14/21 starting at 7am..
- Food Vendors: Please attach a full menu and price listing. Please provide a list of other fairs, festivals, or events in which you have participated.
- Merchandise Vendors: Please attach a picture of booth display. Give a general description of items for sale, display, and include price range. Please provide a list of other fairs, festivals, or events in which you have participated.
- Each booth must provide their own insurance to cover sales, products, and operations. Proof of insurance must be provided one month prior to the event date or the vendor will not be allowed to set up. Insurance requirements will be as follows:
  - o General Liability Aggregate \$1,000,000
  - o Property Damage \$300,000 per occurrence
 Or \$1,000,000 per occurrence combined single limit. DB Adventures must be named as additionally insured if accepted to Crooked Creek Campground Sportsman's Festival.
- I have reviewed the Crooked Creek Campground Sportsman's Festival policies and procedures and agree to abide by the policies as outlined, including that the festival is held rain or shine and that booth fees are non-refundable.

I understand as a vendor of the festival that I am a representative of the festival and will act as an example to the community. **Crooked Creek Campground Sportsman's Festival Vendor Policies**  
**Print and keep a copy of this application for your records**

1. The main focus of this festival is to showcase the Upper Pine Creek and the outdoor industry. The festival may offer music, activities for children, food, sales of hunting/fishing goods/services, and demonstrations of outdoors activities.
2. Vendors may only sell pre-approved items.
3. A 5lb ABC fire extinguisher with a current service tag must be on location for all vendors using electric or an open flame.
4. Vendors may not exceed the limits of their rented booth space, including tent, display, and storage of materials. Should you need more space please purchase a double or triple space ahead of time.
5. Vendors must obtain their own insurance coverage for sales, products, operations, property damage, and personal injury arising as a result of the vendor's action.
6. Vendors must have a PA Sales Tax Number. Vendors are responsible for the licenses and taxes related to their sales.
7. Vendors are responsible for their own insurance. The festival will not be held liable for any damages to you, your merchandise, your display, or your equipment. If you do not have insurance, you can inquire with your homeowner or local agency. If you choose not to have insurance you do so at your own risk. The festival cannot be held liable.
8. Prices of items for sale must be posted and visible to the public. Festival staff will check your posted items against the items listed on your festival application. Vendors selling unapproved items or inflated prices will immediately be shut down.
9. If using a generator this must be known ahead of time.
10. The total amount of the application fee is due at the time of application. Refunds will only be issued if the application is not accepted. A \$25.00 fee will be charged for all returned checks.
11. Illegal paraphernalia cannot be sold or displayed at the festival.
12. Shouting or sales "barking" at festival attendees is discouraged. You may not interfere with the operation of other booths. No solicitation is allowed during the festival. All activity must be maintained within your assigned booth location.
13. Security for your merchandise, booth, and property are your responsibility. Please be watchful.
14. Only registered booth participants will be permitted to conduct business during Crooked Creek Campground Sportsman's Festival.
15. Crooked Creek Campground Sportsman's Festival is a rain or shine event. No refunds will be given.
